Limits: All lines including grade crossings and crossing loops on the ARTC standard, broad and dual-gauge lines between Tottenham Signal TOT8 (10.625km), Albion Junction Signal ALB500 (14.068km), Albion Junction Signal MCT14 (14.695km), McIntyre Loop MCT12 (15.321km), Tullamarine Signal TME20 (25.945km), Somerton Signal SOM2 (21.453km) and Wallan Signal WLN 8 (49.244km)
