OPERATING CONDITIONS (GENERAL DETAILS)

For the Hunter Valley Maintenance Closedown, Local Possession Authorities (LPA) will be authorised up to the Private Line Maintenance Interface Boundaries, as described in the applicable Safety Interface Agreements (IA) listed below.

Where essential maintenance work is required to be carried out less than 500m from the limit of the LPA at the South Maitland Railway Interface the following arrangements will apply.

SAFEWORKING ARRANGEMENTS

In addition to ARTC Network Rules and Procedures NSFW 302 Local Possession Authority and NSFP 700 Using a Local Possession Authority, where worksites are located less than 500m from the end limit of the LPA, it will be permissible to work on the East Greta Arrival and Departure Roads within 500m of the limit of the LPA without a Work on Track Authority adjoining the end limit.

The South Maitland Railway Signaller will be responsible for:

- Ensuring that they provide blocking facilities and do not remove them until the work has been completed, and
- Ensuring that they do not authorise any rail traffic movements toward the ARTC LPA limits whilst a worksite is located within 500m of the LPA limits.

Before the commencement of works

Possession Protection Officer (PPO) must:

- Liaise with Signaller at the South Maitland Rail Signal Box, and
- Obtain an assurance from the Signaller that they have placed blocking facilities on the East Great Arrival and Departure Roads adjacent to the LPA, and
- After agreement has been reached, advise the Protection Officer (PO) of the agreed arrangements and give permission for the work to start.

Protection Officer (PO) must:

- Confirm the agreed arrangements with LPA PPO and South Maitland Railway Signaller.

At the completion of the works:

Protection Officer (PO) must:

- Advise the PPO that the work is completed.

Possession Protection Officer (PPO) must:

- Advise the South Maitland Railway Signal Box that the work is completed.
